

Index Framework

The Kaiko Blue Chip Index Family (the “Indices”) are designed to provide exposure to the largest and most liquid digital assets, and therefore ensure maximum tradability. All components are selected from the Kaiko Investable Universe, a pool of digital assets screened on their liquidity, tradability on vetted exchanges and availability with vetted custodians. Constituents of the Indices is decided based on the total and circulating market capitalization and liquidity based on the trading volume with the 30% capping threshold to ensure the well-diversed portfolio.
